Items brought up for discussion at the NDHSCA Class B Golf Coaches meeting held on Tuesday, May 26, 2009 at Carrington High School and Jamestown High School Tech Center via ITV.

Vic Soholt/ MPCG – golf advisory committee member called the meeting to order and introduced Dave Carlsrud from NDHSAA to confirm regional sites for 2010.

2010 Invitations for the State Class B meet received from:

1. Jamestown Country Club – Girls and Carrington – Boys
2. Hankinson Dakota Winds – Girls and Wahpeton – Boys

Gregg Robbins, Central Cass, moved to accept the invitation from Hankinson, Dakota Winds Golf Course and Wahpeton; second by Washburn - Phil Hentsch. Motion carried 34 in favor and 25 against. Jamestown Country Club and Carrington will serve as a second option.

Vic Soholt – advisory committee member presented the following items for discussion and vote.

Item 1. Cell phone – Golf Regulations, Page 2, Rule 7 should read as follows:

7. A player is to be assessed a 2-stroke penalty for using electronic devices during a round. These items include, but not limited to cell phones, range finders and i-pod devices. The purpose of this rule is to prevent these items from being used **during a tournament. This includes time from the player's first tee shot until the player's last putt is holed and scorecards are turned in to the scoring committee.**

Jon Starky, Napoleon, moved to approve the change in bold print; second by Hazen - K. Berglund Motion carried 37 in favor and 14 against.

Item 2. State Qualifying: Golf Regulations, Page 4 add rule #9.

Class B Boys & Girls: Should four individual players qualify by score from one particular school their scores shall count as a team score at the state meet with a maximum of six qualifiers allowed per school.

Gary Schell, Stanley moved to leave it as an individual qualifier, second by Napoleon-Starky. Motion carried 60 in favor to leave it as an individual qualifier and 1 against. (Proposal failed)

Item 3. Allow Class B Coaches to coach “through the green” as Class A Coaches: Golf Regulations, Page 2, item 14 a-Jiii.

Motion by Watford City-Bettenhausen and second by Central Cass- Robbins, motion carried 31 in favor and 24 against.

Item 4. Fall Golf Proposal: See attached document provided by Kindred High School.

Moved by Kindred-Jensen and second by Grafton-Herbel to support the Fall Golf Proposal, motion failed 35 against and 30 favored the Fall Golf proposal.
